SUBJECT: Non-Discrimination in Employment Policy Statement

It is the policy of Black Girl Health Foundation/BGH Clinic to not discriminate against any person on the basis of race, color, national origin, religion, disability, age, sex (including pregnancy-related conditions and sexual harassment), marital or familial status, sexual orientation or other class protected by law in the admission to or participation in its programs, services, activities, or in employment. This nondiscrimination policy pertains to all individuals of a protected class, including employees, volunteers, trainees, clients, individuals applying for services and other members of the public.

For specific details about processes regarding the documentation and resolution of reports of discrimination, harassment and request for reasonable modification, please refer to the current BGH Clinic Employee Handbook.

All records of alleged discrimination and harassment will be maintained and retained for at least 7 years according to our records retention policy.

This policy is reviewed upon hire of employees and volunteers as well as once a year by all staff during a general staff meeting. This policy is also posted on the BGH Clinic bulletin board and can be shared with anyone upon request.

It is the policy and commitment of Black Girl Health Foundation to not discriminate against clients, other providers, or employees in the provision of services or administration of the programs operated by BGHF/BGH Clinic. To this end, BGH Clinic prohibits discrimination based on race, age, color, sex, national origin, physical or mental disability, religion, or other protected classes. The Chief Compliance Officer, or designee, in collaboration with the Executive Director and our appointed legal counsel, will manage compliance and enforcement with this policy. BGH Clinic will comply with all federal and state non-discrimination laws and as a condition of any application of the implementation of an outpatient psychiatric facility in the state of Pennsylvania and, will submit an assurance as requested/required noting the organizations compliance. All services and employment provided by BGH Clinic will be done in a non-discriminatory manner, without regard to race, sex, color, national origin (address issue of Limited English Proficiency, in the service policy only), ancestry, religious creed, disability, and age.
